BETWEEN NORTH NORTHAMPTONSHIRE COUNCIL ("the Council") and <u>S & A CORBY HOTEL LTD</u> ("the Licensee") who is the owner of premises known as <u>HOLIDAY INN CORBY</u> ("the Premises")

## IT IS AGREED AND DECLARED as follows:

- 1. THIS Licence is made subject to the provisions of the Marriage Act 1949 as amended ("the Act") and The Civil Partnership Act 2004 and in particular to The Marriages and Civil Partnerships (Approved Premises) Regulations 2005 ("the Regulations") made thereunder.
- 2. THIS Licence shall last for three years from the **first day of February 2021 subject** to the provisions of Clause 6 below.
- 3. THE Council grants approval in accordance with the Act for the use of such rooms in the Premises shown on the plan attached to the Certificate of Approval for the solemnisation of marriages, and registration of civil partnerships.
- 4. THE Licensee agrees to comply at all times with the requirements of the Act and the Regulations and in particular to the requirements and conditions which are attached to the Certificate of Approval.
- 5. (a) The Licensee shall forthwith confirm to the Council the name address occupation and where appropriate the position held in the Licensee's organisation of the responsible person being the individual with responsibility for ensuring compliance with the conditions and requirements of this Licence.
  - (b) The Licensee shall notify the Council forthwith if the individual who is the responsible person ceases to be the responsible person and shall confirm to the Council the required details of the new responsible person.
- 6. SUBJECT to serving the requisite notice and to taking into account the representations of the Licensee the Council may revoke this Licence if:
  - (a) any condition or requirements of this Licence have been broken
  - (b) the use of the Premises has changed so that the Council considers that the Premises are no longer suitable as a venue for the solemnisation of marriages and civil partnerships
  - (c) directed to do so by the Registrar General on the ground that there have been in the opinion of the Registrar General breaches of the law relating to marriage or civil partnerships in or on the Premises
- 7. ALL applications notices representations and correspondence from the Licensee shall be addressed to the Registration Manager who is the Proper Officer in this respect of the Council
